July 3, 2019**

1. Estimate to CCTV and High Pressure Cleaning (including Root Removal of 8” VCP and 10” Cast Iron Sanitary) - 11th & 12th Street and Other Area as Directed by White Twp. = \$3,100.00/day from Insight Pipe Contracting. OR, Jet-Vac Truck, CCTV w/ operator & laborer = \$2,800.00/day from Robinson Pipe Cleaning. Tri State as well as Debos were also contacted for an estimate but neither has responded.

The Supervisors agreed that 3 letters shall be sent; 1 to PENNDOT requesting the stop sign; 1 to PTPD requesting more patrols on Clayton Rd.; 1 to the Patterson Twp. Commissioners so they're aware of the issue.
