Reports:

Earned Income Tax: Supervisor DeMeio read that \$15,633.14 was collected in August.

Real Estate Tax & Fire Protection Fee: Nancy Munroe read \$31,635.46 was collected in Real Estate & \$0.00 in Fire Protection Fees for August.

Accounts Payable & Payroll Summary: AP = \$57,153.89 / PR = \$10,483.02

Police: Assistant Chief Bathgate read there were 35 calls for service in August, resulting in 3 traffic citations issued & 1 arrest for Disorderly Conduct.

Code Enforcement: 7 properties were abated; 4 new letters of violation; 3 second/final notices; 8 citations issued.

Fire Department: Supervisor Evans said there was 1 call for service in August. 8/24: MVA with entrapment on 4th Ave. in West Mayfield, however the call was actually in Beaver Falls. 6 Fire Fighters for 0 Man Hours.

Road Crew: Tom Orłowski asked the Supervisors if they've checked out the berm & ditch work that he & Dan Fritzley have been doing on 11th, 12th, 26th and if they had any suggestions.
