2. Multimodal Grant-12<sup>th</sup> Ave. Bridge Project (PennDOT): Grant was awarded in the amount of \$400,600.00 with a 30% local share match required. Engineers are working with PennDOT
3. Small Water & Sewer Grant: Waiting for approval or denial in the amount of \$425,000 for 22<sup>nd</sup> Ave. and Craighead Lane projects. Also, in the amount of \$89,600.00 for Sewer System Cleaning and Televising. Approval/denial pushed back until November tentative
4. Disproportionate Impact Funds: Funds can be used to replace sanitary or storm sewers and repave as restoration of project. Several projects are being looked at, the first projects are.
  - LSSE to submit to county for re-imbursement for project expenditures to date \$79,497.98

  - 12<sup>th</sup> Ave from the bridge project to the Beaver Falls line including a portion of 23<sup>rd</sup> St

The funds may also be used in demolition of blighted properties, approximately 7 properties have currently been identified.
