### ❖ Unfinished Business:

1. Sewer Repair ARPA Funding: 12<sup>th</sup> Ave and @3<sup>rd</sup> Ave have been completed, six inch line 21<sup>st</sup> Ave to 19<sup>th</sup> Ave, Lining completed in process of re-establishing taps  
Is going smoothly and should be completed by the end of the week, one additional tap has been located and is being located to prove where line comes from
2. Multimodal Grant-12<sup>th</sup> Ave. Bridge Project (PennDOT): Grant was awarded in the amount of \$400,600.00 with a 30% local share match required. Engineers are working with PennDOT  
No response from Penn-Dot yet
3. Small Water & Sewer Grant: Waiting for approval or denial in the amount of \$425,000 for 22<sup>nd</sup> Ave. and Craighead Lane projects. Also, in the amount of \$89,600.00 for Sewer System Cleaning and Televising. Approval/denial pushed back until November tentative  
Tentative meeting 11-21-2023
4. Disproportionate Impact Funds: Funds can be used to replace sanitary or storm sewers and repave as restoration of project. Several projects are being looked at, the first projects are.  
Have waterlines located finally but are held up due to loss of a road crew employee

The funds may also be used in demolition of blighted properties, 9 properties have currently been identified.

Progress on purchasing 9 properties Solicitor Bible total cost \$4,163.30 for properties  
Paper work has been signed by both the county and School district  
Solicitor Bible checked with county, county will take a municipal check
